

IMPORTANT-READ INSTRUCTIONS CAREFULLY

1. YOU MUST CONTACT THE MUNICIPAL COURT WITHIN FOURTEEN (14) DAYS from the date of this citation. The address is 516 Ranch House Road, Willow Park Texas 76087. The telephone number is (817) 441-7107.
2. If you wish to Plead Guilty or No Contest, you may do so by contacting the Court Clerk weekdays between the hours of 8:00 a.m. and 5:00 p.m. to pay a predetermined fine plus state fees.
3. If you wish to Plead Not Guilty, your case must be set for trial by mail or by appearing in person before the Clerk of the Court within 14 days from the date of this citation. You will be notified at the address on the citation of your court date. If the address is incorrect you must notify the Clerk of your current mailing address.
4. Failure to appear within the fourteen (14) days as required or failure to appear at your court date will result in the issuance of a WARRANT FOR YOUR ARREST.
5. JUVENILES: All persons age 16 or younger MUST appear in person WITH a parent, legal guardian or proof of marriage.

WARNING

Citations for FAILURE TO MAINTAIN FINANCIAL RESPONSIBILITY (No Liability Insurance): "A SECOND OR SUBSEQUENT CONVICTION OF FAILURE TO MAINTAIN FINANCIAL RESPONSIBILITY WILL RESULT IN THE SUSPENSION OF YOUR DRIVER'S LICENSE AND MOTOR VEHICLE REGISTRATION UNLESS YOU FILE AND MAINTAIN PROOF OF FINANCIAL RESPONSIBILITY WITH THE DEPARTMENT OF PUBLIC SAFETY FOR TWO YEARS FROM THE DATE OF CONVICTION. THE DEPARTMENT MAY WAIVE THEREQUIREMENT TO FILE PROOF OF FINANCIAL RESPONSIBILITY IF YOU FILE SATISFACTORY EVIDENCE WITH THE DEPARTMENT SHOWING THAT AT THE TIME THIS CITATION WAS ISSUED, THE VEHICLE WAS COVERED BY A LIABILITY INSURANCE POLICY OR THAT YOU WERE OTHERWISE EXEMPT FROM THE REQUIREMENTS TO PROVIDE EVIDENCE OF FINANCIAL RESPONSIBILITY."

DISMISSAL OF CERTAIN MISDEMEANOR CHARGES UPON COMPLETION OF DRIVING SAFETY COURSE

Texas Law provides that a Court shall defer proceedings and allow a person 90 days to present a department-approved certificate of course completion as written evidence that, subsequent to the alleged act, the person has successfully completed a driving safety course approved by the court, if: (A) On or before the answer date (14 days from the date of the citation) you enter a plea in person or in writing of No Contest or Guilty and present to the court an oral request or a written request, in person or by mail, to take a course; and (B) You have a valid Texas driver's license or permit; and (C) You have not completed a driving safety course within one year immediately preceding the date of the citation; and (D) You file an affidavit with the Court stating that you are not in the process of taking a course nor have you completed a course that is not yet reflected on your driving record; and (E) The offense charged in the citation is an offense covered by Article 6701d V.A.T.S. except Sec. 51 thereof, and is not for speeding 25 miles an hour or more over the posted speed limit at the place where the alleged offense occurred.
