

ORDINANCE NO. 143

ANNEXING THE HEREINAFTER DESCRIBED TERRITORY TO THE CITY OF WILLOW PARK, PARKER COUNTY, TEXAS AND EXTENDING THE BOUNDARY LIMITS OF SAID CITY SO AS TO INCLUDE SAID HEREINAFTER DESCRIBED PROPERTY WITHIN SAID CITY LIMITS, AND GRANTING TO ALL THE INHABITANTS OF SAID PROPERTY ALL OF THE RIGHTS AND PRIVILEGES OF OTHER CITIZENS AND BINDING SAID INHABITANTS BY ALL OF THE ACTS, ORDINANCES, RESOLUTIONS AND REGULATIONS OF SAID CITY.

WHEREAS, a petition has been signed by a majority of the inhabitants qualified to vote for members of the State Legislature and who are citizens of the State of Texas and inhabitants of the following described territory, to-wit:

WHEREAS, said territory is adjoining the City of Willow Park, and

WHEREAS, said petition, desiring and requesting the annexation of said territory to said city, has been presented to the City (Council or Commission) and has attached to it the affidavit of three (3) of said applicants to effect that said petition is signed by a majority of the qualified voters within such property:

NOW THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF WILLOW PARK, TEXAS:

That the Following described property, to-wit:

All That Certain lot, tract or parcel of land lying and being situated in Parker County, Texas contained within following metes and bounds:

BEGINNING at a concrete marker at the Northwest corner of the intersection of Farm Road 5 and Bankhead Road, thence in a Northerly direction being with the West R.O.W. line of said Farm Road 5 to its intersection with Interstate 20 to a point for corner;

THENCE in an Easterly direction being with the East boundary line of said County road to its intersection with Bankhead Road to a point for a corner,

THENCE in a Westerly direction being with the North boundary line of Bankhead Road to its intersection with the west boundary line of Farm Road 5 being a concrete marker at the point of beginning.

Be and the same is hereby annexed to the City of Willow Park, Parker County, Texas and that the boundary limits of the City of Willow Park be and the same are hereby extended to include the above described territory within the city limits of the City of

Willow Park, and the same shall hereafter be included within the territorial limits of said city, and the inhabitants thereof shall hereafter be entitled to all rights and privileges of other citizens of the City of Willow Park and they shall be bound by the acts, ordinances, resolutions and regulations of said city.
