

CITY OF WILLOW PARK

ORDINANCE NO 463-00

AN ORDINANCE REVISING THE RATES, TARIFFS, AND CHARGES OF SOUTHERN UNION GAS COMPANY FOR NATURAL GAS SERVICE WITHIN THE CITY OF WILLOW PARK AND DECLARING THIS ORDINANCE TO BE A FINAL DETERMINATION OF RATES.

WHEREAS, on September 26, 2000, Southern Union Gas Company filed its Statement of Intent to Change the Rates within the City of Willow Park-, and

WHEREAS, the City Council of the City of Willow Park, after study and consideration of the Company's Statement of Intent, desires to establish the maximum rates to be charged general service customers for gas service with the City of Willow Park, and

WHEREAS, this City Council has found, and does hereby find, that an increase in base rates and charges of Six Thousand Sixty-Seven Dollars (\$6,067.00) per annum from the general service customers of the Company in the City of Willow Park, Texas will meet all requirements of law, no proposition is to appear on the ballot in that election; and

WHEREAS, this City Council has found, and does hereby find, that the authorized increase in rates should be recovered according to the rates and charges set forth on the attached tariffs; and

NOW THEREFORE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLOW PARK, TEXAS:

Part 1 - An increase in base rates and charges of Southern Union Gas Company for natural gas sold within the City of Willow Park is approved in

amount which recovers from the City of Willow Park customers Six Thousand Sixty-Seven Dollars (\$6,067.00) base rate increase.

Part 2 - The attached tariffs are hereby approved.

Part 3 - Nothing in this Ordinance shall be construed now or hereafter as limiting or modifying in any manner, the right and power of the City of Willow Park under the law to regulate the rates and charges of Southern Union Gas Company.

Part 4 - The rates and charges approved herein shall be effective for meters read in and after OCTOBER 31, 2000.
