ORDINANCE NO. 551-06

AN ORDINANCE PROVIDING FOR CANVASSING AND DECLARING THE RESULTS OF THE GENERAL ELECTION CONDUCTED MAY 13, 2006 FOR THE ELECTION OF CERTAIN MUNICIPAL OFFICERS FOR THE CITY OF WILLOW PARK; MAYOR, COUNCIL MEMBERS: PLACE 1, PLACE 2, PLACE 3, PLACE 4, AND PLACE 5; PROVIDING A SEVERABILITY CLAUSE; AND, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Willow Park, TX (“City”) is a municipal corporation organized under the laws of the State of Texas; and

WHEREAS, it is the intent of the City of Willow Park to protect the health, safety, welfare and well being of its citizens; and

WHEREAS, the City Council consists of a Mayor and five council members elected according to a place system for staggered two year terms of office; the unexpired terms of office for Mayor, Council Member, Place No. 1, and Council Member, Place No. 2 will expire in May 2007 and the terms of office for Council Member Place 3, Place 4, and Place 5 will expire in May 2008; and

WHEREAS, Chapter 1, *General Provisions*, Article 1.300 *Municipal Election* provides that “all elections pertaining to municipal affairs shall be governed by the election laws of the State of Texas.” and,

WHEREAS, the general election for certain municipal officers of the City was ordered to be held on May 13, 2006 pursuant to Ordinance 548-06 adopted on February 21, 2006; and

WHEREAS, the election so ordered for the City was ordered not later than 62 days before the election day pursuant to §3.005(a), TEX. ELECTION CODE; and,

WHEREAS, May 13, 2006 is the second Saturday in May, which is prescribed as a uniform election date under §41.001 TEX. ELECTION CODE; and

WHEREAS, the City did, on the 21st day of February, 2006 by Ordinance No. 548.06, order a

general election to be held on May 13, 2006 for the purpose of electing a Mayor and Council Members for Place 1, 2, 3, 4 and 5; and

WHEREAS, the City Council has investigated all matters pertaining to the general election and has determined that notice of said general election was given as required by law, and said elections were duly and legally held on May 13, 2006, in conformity with the election laws of the State of Texas, and the Voting Rights Act of 1965, and the results of said general election has been certified and returned to the City Council by the proper judges and clerks thereof; and

WHEREAS, on May 19, 2006, the returns of the general election were duly made by the Parker County Election Division and filed with the City; and

WHEREAS, the “Canvass Report to the City of Willow Park” for the May 13, 2006 general election has been presented by the Mayor to the Council and is attached hereto as Exhibit “A” and included herein.

NOW THEREFORE: BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLOW PARK, TEXAS:

SECTION 1. RECITALS

All of the above precatory statements are true and correct and incorporated herein for all purposes.

SECTION 2. ELECTION RETURN CANVASS

The tabulation of votes cast for the office of Mayor and Council Members in the General Election held on May 13, 2006, made and certified to by the City Secretary of the City of Willow Park, is hereby
