NOTICE OF UTILITY APPLICANT

APPLICANT HEREBY AGREES: That any current or other unpaid account of Applicant, either business, corporate or personal, may be transferred to the account where service is herein applied for, or to any other account in name of applicant or business of applicant, and upon such transfer such account shall become a part of the new account or any other account in name of applicant or applicant's business. Applicant further agrees to pay for all water furnished to, or waste water discharged from, (collectively "service") to the above mentioned premises according to meter readings and rates prescribed by the City until this agreement is cancelled in writing and signed by applicant with the City. That the City may discontinue water service at any time waste water or otherwise resulting from defective plumbing, broken or faulty service or water mains, or from any condition of the water itself or any substance that may be mixed with or to be in the water furnished to applicant.

1. The deposit shown on the face hereof shall bear no interest.
2. Water bills must be paid on or before delinquent date shown thereon, otherwise a penalty will be enforced.
3. In the event bills are not paid on or before delinquent date, water service may be discontinued to service address, and not resumed until all past due service bills are paid, together with a charge for re-connection.
4. The applicant shall not sell to others or otherwise dispose of any of the service supplied hereunder.
5. The duly authorized agents and employees of the City shall have access to the applicant's premises at all times for the purpose of installing meters and other apparatus which the City may desire to install therein in connection with the furnishing of service hereunder and for the purpose of reading meters and inspecting, repairing or removing the property of the City installed upon the applicant's premises.
6. Unless applicant leaves Willow Park with a signed disconnect & forwarding address, deposit will be forfeited.

The applicant will not permit anyone except employees of the City to tamper or in any way interfere with said meter or other property of the City installed upon the applicant's premises. Upon failure of the applicant to observe this requirement the City may discontinue service without notice.
